# NOTICE OF PUBLIC MEETING

To be held by the Planning and Housing Committee (Under the Planning Act)

Proposed Technical Amendments to City of Toronto Zoning By-law 569-2013

**Location of Application:** City-wide **Applicant:** City-initiated

#### **PROPOSAL**

The City of Toronto is proposing to enact technical amendments to the City of Toronto Zoning By-law 569-2013 which regulates the use of land, the size and location of buildings and structures and parking and loading in the City.

The technical amendments include corrections of typographical errors, mapping corrections, wording additions, removal, relocation, and modification of regulations.

## **Technical Amendments to the Maps of Zoning By-law 569-2013:**

- 26 Glazebrook Avenue: corrects the boundary on the lot coverage overlay map value from no value to 33%.
- 28 Glazebrook Avenue: corrects boundaries on the zoning by-law map zone from the zone label RD (f9.0; a275) to CR 1.0 (c1.0; r1.0) SS2; the height overlay map value from HT 10.0, ST 2 to HT 10.5, ST 3; and the lot coverage overlay map value from 35% to 33%.
- 6020 and 6030 Bathurst Street: moves on the zoning by-law map the holding symbol (H) from the end to the front of the zone label (H) RAC (f30.0; a1375; d1.5).
- 3575-3583 Kingston Road: corrects on the zoning by-law map the zone label RD (f7.3; a180) (x410) to RD (f7.3; a180; d0.8) (x410).
- 47A-49D Carrera Boulevard: adds the lands to the zoning by-law map with the zone label RT (x370); the policy overlay map, the height overlay map, and the lot coverage overlay map with no values.

## Technical Amendments to the following Regulations of Zoning By-law 569-2013:

These changes may affect the approval of building permits, zoning certificates or other applications for a minor variance, a consent to sever, an amendment to a zoning by-law, an Official Plan amendment or a Minister's zoning order and any appeals of these matters, as well as outstanding appeals of Zoning By-law 569-2013.

**If you wish to be notified** of the decision of the City of Toronto by-law amendment, you must make a written request to the City Clerk, Attention: Nancy Martins, Administrator, Planning and Housing Committee, at the address, fax number or e-mail set out in this notice.

**Zoning By-law Amendments Appeal:** If a person or public body would otherwise have an ability to appeal the decision of the Council of the City of Toronto to the Ontario Land Tribunal but the person or public body does not make oral submissions at a public meeting or make written submissions to the City of Toronto before the proposed amendments are passed or refused, the person or public body is not entitled to appeal the decision and may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal unless, in the opinion of the Tribunal there are reasonable grounds to do so. You may submit comments to the City Clerk, Attention: Nancy Martins, Administrator, Planning and Housing Committee, at the address, fax number or e-mail set out in this notice.

**People writing or making presentations at the public meeting:** The *City of Toronto Act, 2006*, the *Planning Act*, and the City of Toronto Municipal Code authorize the City of Toronto to collect any personal information in your communication or presentation to City Council or its committees.

The City collects this information to enable it to make informed decisions on the relevant issue(s). If you are submitting letters, faxes, e-mails, presentations or other communications to the City, you should be aware that your name and the fact that you communicated with the City will become part of the public record and will appear on the City's website.
