**PROPOSAL** 

The City of Toronto (City Planning and Development Review Division) has undertaken a comprehensive study for the area generally north and south of the Sheppard Avenue East corridor generally bounded by west of Bayview Avenue and east of Leslie Street. The study has resulted in a proposed amendment to the Official Plan to create the Renew Sheppard East Secondary Plan for the study area.

The Secondary Plan will provide a policy framework to guide future growth in the corridor. It will put in place policies to manage growth within the area including policies related to land use, public realm, parkland, mobility, built form, servicing and transportation infrastructure, and community services & facilities. A copy of the draft Renew Sheppard East Secondary Plan can be found on the study's webpage.



### **FURTHER INFORMATION**

**If you wish to be notified** of the decision of the City of Toronto on the proposed Official Plan Amendment, you must make a written request to the City Clerk attention: Matthew Green, Administrator, North York Community Council, at the address, fax number or e-mail set out above.

Official Plan Amendment Appeal: If a specified person or public body as defined under the Planning Act or the registered owner of any land to which the plan would apply would otherwise have an ability to appeal the decision of the Council of the City of Toronto to the Ontario Land Tribunal but the specified person or public body as defined under the Planning Act or the registered owner of any land to which the plan would apply does not make oral submissions at a public meeting

or make written submissions to the City of Toronto before the proposed Official Plan Amendment is adopted, the specified person or public body as defined under the Planning Act or the registered owner of any land to which the plan would apply is not entitled to appeal the decision to adopt the proposed Official Plan Amendment.

**People writing or making presentations at the public meeting:** The *City of Toronto Act, 2006*, the *Planning Act*, and the City of Toronto Municipal Code authorize the City of Toronto to collect any personal information in your communication or presentation to City Council or its committees.

The City collects this information to enable it to make informed decisions on the relevant issue(s). If you are submitting letters, faxes, e-mails, presentations, or other communications to the City, you should be aware that your name and the fact that you communicated with the City will become part of the public record and will appear on the City's website. The City will also make your communication and any personal information in it - such as your postal address, telephone number or e-mail address - available to the public, unless you expressly request the City to remove it.

Many Committee, Board and Advisory Body meetings are broadcast live over the internet for the public to view. If you speak at the meeting you will appear in the video broadcast. Video broadcasts are archived and continue to be publicly available. Direct any questions about this collection to City Clerk's Office at the telephone number or email address set out above.
