#### **PROPOSAL**

Phase 2 of the project proposes to amend the Zoning By-law to construct a 40-storey residential building with 546 residential units of which 35 will replace the existing rental units on site, along with 304 vehicular parking spaces and 598 bicycle parking spaces at the property at 90 Eastdale Avenue.

This land is also subject to an application under the Planning Act for Rental Housing Demolition and Replacement of the 35 rental units on site, Application Number 23 201074 STE 19 RH.

**If you wish to be notified** of the decision of the City of Toronto on the proposed passing or refusal of the proposed Zoning By-law Amendment, you must make a written request to the City Clerk Attention: Cathrine Regan, Administrator, Toronto and East York Community Council, at the address, fax number or e-mail set out above.

Zoning By-law Amendment Appeal: If a person or public body would otherwise have an ability to appeal the decision of the Council of the City of Toronto to the Ontario Land Tribunal but the person or public body does not make oral submissions at a public meeting or make written submissions to the City of Toronto before the proposed Zoning By-law Amendment is passed or refused, the person or public body is not entitled to appeal the decision.

or refused the person or public body may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to add the person or public body as a party.
