# NOTICE OF PUBLIC MEETING

To be held by Toronto and East York Community Council (Under the Planning Act)

Request to Amend the Zoning By-law Application Number 25 106500 STE 09 OZ

**Location of Application:** 1325 Bloor Street West and 17 Dora Avenue

Applicant: City of Toronto

**Date:** June 5, 2025

Time: 10:00 a.m., or as soon as possible thereafter

Place: Committee Room 1, Toronto City Hall and by Video Conference

#### **PROPOSAL**

The application to amend the Zoning By-law proposes to permit the construction of the new Bloor-Lansdowne GO/SmartTrack station for the property at 1325 Bloor Street West and 17 Dora Avenue. The Bloor-Lansdowne GO/SmartTrack station is part of the SmartTrack program, which is a collaboration between the Province of Ontario, the City of Toronto, and Metrolinx for implementing new GO Stations in Toronto. The station will be located on the Metrolinx-Barrie rail corridor, connecting with destinations such as Caledonia, Downsview Park, Aurora, Newmarket, Barrie and Union Station. The station will also be served with two-way all-day increased service frequency as part of the GO Expansion plan.

The main entrance building will be located at 1325 Bloor Street West, which is planned to abut a new mixed-use tall building development on an adjacent property at 1319 Bloor Street West. A maintenance building with bicycle parking and a waste and recycling storage area will be located at 17 Dora Avenue. Other station elements, including the east and west platforms, waiting enclosures, a pedestrian tunnel from the main entrance building to access the westerly platform, stairs and elevators, will be located within the rail corridor. The station design also includes a multi-use path (MUP) running parallel to the east side of the railway corridor from south of Dublin Street to Bloor Street West. This MUP is proposed to continue north to Paton Road. This segment is not included in the properties subject to this application.

This land is also subject to an application under the Planning Act for minor variance. Application Number A0225/25 TEY.



# Zoning By-law Amendment Appeal: If a

specified person or public body as defined under the Planning Act or the registered owner of any land to which by-law would apply would otherwise have an ability to appeal the decision of the Council

of the City of Toronto to the Ontario Land Tribunal but the specified person or public body as defined under the Planning Act or the registered owner of any land to which the by-law would apply does not make oral submissions at a public meeting or make written submissions to the City of Toronto before the proposed Zoning By-law Amendment is passed, the specified person or public body as defined under the Planning Act or the registered owner of any land to which the by-law would apply is not entitled to appeal the by-law.

**People writing or making presentations at the public meeting:** The *City of Toronto Act, 2006*, the *Planning Act*, and the City of Toronto Municipal Code authorize the City of Toronto to collect any personal information in your communication or presentation to City Council or its committees.

The City collects this information to enable it to make informed decisions on the relevant issue(s). If you are submitting letters, faxes, e-mails, presentations, or other communications to the City, you should be aware that your name and the fact that you communicated with the City will become part of the public record and will appear on the City's website. The City will also make your communication and any personal information in it - such as your postal address, telephone number or e-mail address - available to the public, unless you expressly request the City to remove it.
