## NOTICE OF PUBLIC MEETING

To be held by North York Community Council (Under the Planning Act)

Request to Amend the Zoning By-law Application Number 25 124861 NNY 06 OZ

**PROPOSAL** 

The application to amend Zoning By-law 1082-2022 proposes to increase the maximum unit count from 1,400 units to 1,700 units, to reduce the minimum size of 2-bedroom and 3-bedroom units and to amend the performance standard relating to the timing of services at 1350 Sheppard Avenue West. The zoning by-law amendment proposal also includes some technical modifications to Schedule A of Zoning By-law 1082-2022. The proposed zoning amendments only apply to Phase 1 of the William Baker / Arbo District, as noted on the key map on the second page of this notice.

The lands are also subject to an application under the Planning Act for approval of Plan of Subdivision, Application Number No. 21 119572 NNY 06 SB.



## **FURTHER INFORMATION**

If you wish to be notified of the decision of the City of Toronto on the passing or refusal of the proposed Zoning By-law Amendment, you must make a written request to the City Clerk attention: Matthew Green, Administrator, North York Community Council, at the address, fax number or e-mail set out above.

Zoning By-law Amendment Appeal: If a specified person or public body as defined under the Planning Act or the registered owner of any land to which the plan or by-law would apply would otherwise have an ability to appeal the decision of the Council of the City of Toronto to the Ontario Land Tribunal, but the specified person or public body as defined under the Planning Act or the registered owner



of any land to which the plan or by-law would apply does not make oral submissions at a public meeting or make written submissions to the City of Toronto before the proposed Zoning By-law Amendment is passed, the specified person or public body as defined under the Planning Act or the registered owner of any land to which the plan would apply is not entitled to appeal the decision to adopt the proposed Official Plan Amendment or the by-law.

**Standalone Zoning By-law Amendment Appeal:** If a specified person or public body as defined under the Planning Act or the registered owner of any land to which by-law would apply would otherwise have an ability to appeal the decision of the Council of the City of Toronto to the Ontario Land Tribunal but the specified person or public body as defined under the Planning Act or the registered owner of any land to which the by-law would apply does not make oral submissions at a public meeting or make written submissions to the City of Toronto before the proposed Zoning By-

law Amendment is passed, the specified person or public body as defined under the Planning Act or the registered owner of any land to which the by-law would apply is not entitled to appeal the bylaw.

**People writing or making presentations at the public meeting:** The *City of Toronto Act, 2006*, the *Planning Act*, and the City of Toronto Municipal Code authorize the City of Toronto to collect any personal information in your communication or presentation to City Council or its committees.

The City collects this information to enable it to make informed decisions on the relevant issue(s). If you are submitting letters, faxes, e-mails, presentations, or other communications to the City, you should be aware that your name and the fact that you communicated with the City will become part of the public record and will appear on the City's website. The City will also make your communication and any personal information in it - such as your postal address, telephone number or e-mail address - available to the public, unless you expressly request the City to remove it.

Many Committee, Board and Advisory Body meetings are broadcast live over the internet for the public to view. If you speak at the meeting you will appear in the video broadcast.
