# NOTICE OF PUBLIC MEETING

### **PROPOSAL**

The application proposes to demolish a 11-storey apartment building containing 26 rental units located at 133 Erskine Avenue. The 26 rental units are proposed to be replaced as part of the new 35-storey building comprised of 364 dwelling units. Tenant relocation and assistance is proposed to mitigate hardship. A related Official Plan and Zoning By-law Amendment Application (21 251207 NNY 15 OZ) has been approved by the Ontario Land Tribunal.

A Rental Housing Demolition and Conversion application (21 251215 NNY 15 RH) under Section 111 of the *City of Toronto Act*, 2006 (Chapter 667 of the Municipal Code) has been submitted to permit the demolition. Under the *City of Toronto Act*, 2006, the demolition of a rental property with six or more dwelling units is prohibited without obtaining a permit from the City. Decisions by City Council on the rental housing demolition application are not subject to appeal to the Ontario Land Tribunal (OLT).
