NOTICE OF ADOPTION OF OFFICIAL PLAN AMENDMENT 410 AND NOTICE OF PASSING OF ZONING BY-LAW 623-2025 (Under the Planning Act)

TAKE NOTICE that the City of Toronto adopted Official Plan Amendment 410 (By-law 624-2025) to the former City of Toronto Official Plan on June 26, 2025. Zoning By-law 623-2025 was also passed on this date, with respect to the lands known as 215 Lake Shore Boulevard East (Phase 1).

An explanation of the purpose and effect of the Official Plan Amendment and Zoning By-law, and a map showing the location of the lands to which the amendments apply, are attached. The amendments were processed under file number: 24 231978 STE 10 OZ.

A statutory public meeting was held on April 3, 2025 and the Toronto and East York Community Council and Toronto City Council considered one oral and two written submissions in making the decision. Please see item TE21.8 at <u>https://secure.toronto.ca/council/agenda-</u>item.do?item=2025.TE21.8.

This land is also subject to applications under the Planning Act for approval of a subdivision (Application Number 17 180289 STE 28 SB), site plan control (Application Number 17 228459 STE 28 SA), an amendment to a zoning by-law and official plan (Application Number 21 110243 STE 10 OZ), and for consent (Application Number 24 210316 STE 10 CO).

IF YOU WISH TO APPEAL TO THE ONTARIO LAND TRIBUNAL:

Take notice that an appeal to the Ontario Land Tribunal in respect to all or part of this Official Plan Amendment and/or Zoning By-law may be made by filing a notice of appeal with the City Clerk, **Attention: Raneisha Hemmings**, Registrar Secretariat, 100 Queen Street West, 2nd Floor West, Toronto, ON, M5H 2N2, no later than 4:30 p.m. on **July 22, 2025**. If delivering in-person, drop off at the Registry Services Counter, Toronto City Hall. The filing of a notice of appeal after 4:30 p.m., in person or electronically, will be deemed to have been received the next business day.

A Notice of Appeal must:

- (1) set out the specific part of the proposed Official Plan Amendment to which the appeal applies;
- (2) set out the reasons for the appeal of the proposed Official Plan Amendment and/or Zoning By-law; and
- (3) be accompanied by the fee charged by the Ontario Land Tribunal, currently in the amount of \$1,100.00 for each application appealed, payable by certified cheque or money order to the Minister of Finance, Province of Ontario.

If you wish to appeal to the Ontario Land Tribunal (OLT) or request a fee reduction for an appeal, forms are available from the OLT website at <u>www.olt.gov.on.ca</u>.

The proposed Official Plan Amendment is exempt from approval by the Minister of Municipal Affairs and Housing. The decision of Toronto City Council to adopt the proposed Official Plan Amendment is final if a notice of appeal is not received before or on the last day for filing a notice of appeal.

Who Can File An Appeal:

Official Plan Amendment: Only a specified person or public body as defined in the *Planning Act* that made oral submissions at a public meeting or written submissions to the Council before the plan was adopted, the registered owner of any land to which the plan would apply that made oral submissions at a public meeting or written submissions to the Council before the plan was adopted, the Minister and, in the case of a request to amend the plan, the person or public body that made the request may appeal the decision of Council to the Ontario Land Tribunal.

Zoning By-law Amendment: Only an applicant, a specified person or public body as defined in the *Planning Act* that made oral submissions at a public meeting or written submissions to the Council before the by-law was passed, the registered owner of any land to which the by-law would apply that made oral submissions at a public meeting or written submissions to the Council before the by-law was passed, and the Minister may appeal the by-law to the Ontario Land Tribunal.

No person or public body shall be added as a party to the hearing of the appeal unless, before the Official Plan Amendment was adopted or before the by-law was passed, the person or public body made oral submissions at a public meeting or written submissions to the Council or, in the opinion of the Ontario Land Tribunal, there are reasonable grounds to add the person or public body as a party.

PURPOSE AND EFFECT OF OFFICIAL PLAN AMENDMENT 410 AND ZONING BY-LAW 623-2025

The purpose and effect of Official Plan Amendment 410 and Zoning By-law 623-2025 is to increase the heights of the three previously approved mixed-use buildings from 49, 39 and 14 storeys to 54, 44 and 15 storeys (175m, 144.7m, and 58m, respectively, including mechanical space) on the lands known as 215 Lake Shore Boulevard East (Phase 1).

Zoning By-law 623-2025 will also amend the site-specific parking requirements to align with contemporary requirements for Parking Zone A in Zoning By-law 569-2013.
