NOTICE OF PASSING OF ZONING BY-LAW 510-2026

TAKE NOTICE that the City of Toronto passed Zoning By-law 510-2026 on May 21, 2026, with respect to the lands known as 55-77 Davisville Avenue.

An explanation of the purpose and effect of the Zoning By-law, and a map showing the location of the lands to which the amendment applies, are attached. The amendment was processed under file number: 25 199458 STE 12 OZ.

A statutory public meeting was held on April 1, 2026, and the Toronto and East York Community Council and Toronto City Council considered one oral and five written submissions in making the decision. IF YOU WISH TO APPEAL TO THE ONTARIO LAND TRIBUNAL:

Take notice that an appeal to the Ontario Land Tribunal in respect to all or part of this Zoning By-law may be made by filing a notice of appeal with the City Clerk, **Attention: Raneisha Hemmings**, Registrar Secretariat, 100 Queen Street West, 2nd Floor West, Toronto, ON, M5H 2N2, no later than 4:30 p.m. on **June 17, 2026**. If delivering in-person, drop off at the Registry Services Counter, Toronto City Hall. The filing of a notice of appeal after 4:30 p.m., in person or electronically, will be deemed to have been received the next business day.

A Notice of Appeal must:

- (1) set out the reasons for the appeal; and
- (2) be accompanied by the fee prescribed under the Ontario Land Tribunal in the amount of \$1,100.00 for each application appealed payable by certified cheque or money order to the Minister of Finance, Province of Ontario.

If you wish to appeal to the Ontario Land Tribunal (OLT) or request a fee reduction for an appeal, forms are available from the OLT website at <http://www.olt.gov.on.ca/>.

Who Can File An Appeal:

Only an applicant, a specified person or public body as defined in the *Planning Act* that made oral submissions at a public meeting or written submissions to the Council before the by-law was passed, the registered owner of any land to which the by-law would apply that made oral submissions at a public meeting or written submissions to the Council before the by-law was passed, and the Minister may appeal the by-law to the Ontario Land Tribunal.

No person or public body shall be added as a party to the hearing of the appeal unless, before the by-law was passed, the person or public body made oral submissions at a public meeting or written submissions to the Council, or in the opinion of the Ontario Land Tribunal, there are reasonable grounds to add the person or public body as a party.

PURPOSE AND EFFECT OF ZONING BY-LAW 510-2026

The purpose and effect of Zoning By-law 510-2026 is to permit a 121.5-metre (37-storeys excluding mechanical penthouse) residential building with approximately 29,271 square metres of total gross floor area at 55-77 Davisville Avenue. A new mid-block connection is proposed along the east lot line from Davisville Avenue to Balliol Street. A new 406-square-metre park is also proposed on site, with frontage along Balliol Street.

The application also proposes to retain the existing 29-storey rental apartment building at 77 Davisville containing 483 rental dwelling units.
